Police Misconduct Hearing: 20th to 24th May 2024

A misconduct hearing will be held at Police Headquarters, Glan-y-Don, Colwyn Bay, LL29 8AW commencing at 1000hrs on Monday 20th May 2024.

Constable 3210 Daniel Jones faces the following allegation:

On 10th December 2022 Constable 3210 Daniel Jones was on a night out in Liverpool with colleagues from North Wales Police and during the evening he danced in front of Ms. A rubbing his penis area against her knees, actions which were unwanted and displayed a lack of respect. It is also alleged that Constable 3210 Daniel Jones ran his hand down Ms. A's back and swiped over her buttocks area. At an earlier stage in the evening, it is alleged that Constable 3210 Daniel Jones made derogatory statements to a colleague regarding Ms. A.

It is alleged that Constable 3210 Daniel Jones breached the Standards of Professional Behaviour relating to Authority, Respect and Courtesy and Discreditable Conduct.

The allegations above have been assessed by the Appropriate Authority as amounting to Gross Misconduct.

A misconduct hearing will be held at Police Headquarters, Glan-y-Don, Colwyn Bay, LL29 8AW commencing at 1000hrs on Monday 12th August 2024.

Constable 3352 Owain Lewis faces the following allegation:

On 30th September 2022 Constable 3352 Owain Lewis was off duty when he attended at an address in the Buckley area of Flintshire. Whilst at the property it is alleged that Constable 3352 Owain Lewis engaged in an altercation with two other persons, more specifically attempting to assault one of the persons, causing damage to property, throwing items and being verbally abusive.

On 16th December 2022 Constable 3352 Owain Lewis was off duty when he attended at an address in the Buckley area of Flintshire. Whilst at the property it is alleged that Constable 3352 Owain Lewis was verbally abusive and aggressive towards a female at the address and caused damage to her mobile phone.

It is alleged that Constable 3352 Owain Lewis breached the Standards of Professional Behaviour relating to Discreditable Conduct.

The allegations above have been assessed by the Appropriate Authority as amounting to Gross Misconduct.

On Monday 19th August 2024, whilst off duty PC Jones is alleged to have punched a male to the head in Rhyl, without any immediate provocation, in a manner which is considered to be unjustified and unnecessary.

It is alleged that Constable Jones has breached the Standards of Professional Behaviour relating to Authority, Respect and Courtesy, Use of Force and Discreditable Conduct.

That breach is considered to be Gross Misconduct.
