In response to your recent request for information regarding;

- **The number of people aged 18 or under who have been victim to either a confirmed or suspected spiking incident.**

I would like this information broken down by the following, where that information is available:

- **Age**
- **Gender**
- **Suspected method of spiking, e.g. vaping or drink or needle**
- **Whether the incident occurred at an place of education, for example school or college**
- **Whether the victim required any treatment at hospital**
- **Date of the incident**

I would like this information for the past five years to the most recent date available, or as far back as possible given the cost and time parameters allowed under the FoI Act.
