In response to your recent request for information regarding;

I would like to know how many incidents you were called to involving an XL Bully dog in the past 12 months?

How many arrests have been made following an incident involving an XL Bully dog in the past 12 months?

Specifically, I would like to know the arresting offences and outcome of each arrest (i.e. charged, released without charge, caution, etc)

Our information is set up and searchable for our policing purposes. We have retrieved the following data from our system by conducting a keyword search for 'XL Bully' in Occurrence Summary or Enquiry Log 07/11/24 - 07/11/25. To establish the occurrence is relevant to your request would involve manually reviewing each record on our force system. The cost of providing you with the information is above the amount to which we are legally required to respond i.e. the cost of retrieving the information exceeds the 'appropriate level' as stated in the Freedom of Information (FOI) Fees and Appropriate Limit regulations 2004.

Therefore, in accordance with the FOI Act 2000 the information you have requested is exempt under Section 12 (1), and this letter acts as a Refusal Notice under section 17 (5) of the legislation.

Although excess cost removed the forces obligations under the Freedom of Information Act, as a gesture of goodwill, I have supplied information, relative to your request, retrieved or available before it was realised that the fees limit would be exceeded. I trust this is helpful, but it does not affect our legal right to rely on the fees regulations for the remainder of your request.
