2025/598 - murders, attempt murders and manslaughter charges

Although excess cost removed the forces obligations under the Freedom of Information Act, as a gesture of goodwill, I have supplied information, relative to your request, retrieved or available before it was realised that the fees limit would be exceeded. I trust this is helpful, but it does not affect our legal right to rely on the fees regulations for the remainder of your request.

In response to your recent request for information regarding;

I'm researching certain crime within the Rhyl LL18 postcode area I'm seeking to find out how many murders, attempt murders and manslaughter charges have been brought in this post code from 1985 to 2025 including the latest against Catherine Fkynn last year. Please include the most common of these serious offences within DV incidents.

I appreciate the RMS system was not in place during 1985 but the old CRIMES system held that information.
