Therefore, in accordance with the Freedom of Information Act 2000, this letter acts as a Refusal Notice under section 17 (1) of the legislation.

Additionally, concerns have been raised in relation to disclosing the kennels for seized dogs.

Therefore, a public Interest Test has been carried out to weigh up the reasons for and against disclosure; to ensure the release is in the interest of the public as a whole and not just the applicant.

Section 31 (1) Law Enforcement

Section 38 (1) Health and Safety

These exemptions is a prejudice based qualified exemption, therefore there is a requirement to articulate the harm that would be caused in confirming or not that the information is held as well as carrying out a public interest test.

Overall Harm

Disclosure of kennels providers can undermine the process of preventing or detecting crime and put the facilities at risk.

Section 38 provides an exemption from disclosing information if it would endanger any individual (including the applicant, the supplier of the information or anyone else).

The exemption does not necessarily deal with what are commonly thought of as health and safety matters such as establishing the cause of an accident.

Section 38 focuses on two particular areas where disclosure of information would or would be likely to endanger:

- i. the physical or mental health of any individual, or
- ii. the safety of any individual.

Disclosure of businesses/organisations details not in the public domain is likely to cause issues, distress and upset to those working there.

Public Interest Test – S31(1) Law Enforcement:

Considerations favouring disclosure

The public can have informed discussions on the matter.

Disclosure could lead to better public awareness of its activities and its resources.

Considerations favouring non-disclosure

Any individuals currently under investigation could also use the information released to attempt to influence the outcome of the investigation, through intimidate or harassment of the witnesses etc.

Therefore, by applying an exemption providing further information would prevent law enforcement resources from being compromised and would retain the Police force's ability to prevent and detect crimes.

Public Interest Test - Section 38(1) Health & Safety

Considerations favouring disclosure

The public can have informed discussions on the matter.

Considerations favouring non-disclosure

It would be appear unfair to place into the public domain information which is likely to cause an individual, for example the facility, distress as disclosure could cause unwanted contact /attention from those interested in this case and possibly intimidation or harassment.

Balancing Test

The issues of accountability and transparency are noted. However, there is some information in the public domain and North Wales Police have answer Freedom of Information requests regarding this

case. We cannot release further information that would compromise law enforcement role of the force or put individuals at risk.

It is recognised that transparency is the fundamental objective of the Freedom of information Act and this leads itself to a presumption of disclosure. However, this has to be balanced against the harm that would be caused to law enforcement and individuals by providing kennel names.

It is in this case the decision is for non-disclosure.

In accordance with the Freedom of Information Act 2000, this letter acts as a Refusal Notice under section 17 (1) of the legislation.

1 Introduction

Procurement is the process of acquiring goods, works and services, covering both acquisitions from third parties and from in-house providers. The process spans the whole-life cycle from identification of needs, through to the end of a service contract or the end of the useful life of an asset including responsible disposal. It involves initial option appraisal and critical 'make or buy' decisions, which may result in the provision of in-house services in appropriate circumstances.

This Procurement and Contract Management Strategy applies to the procurement of goods, services, utilities and works, and subsequent contract management undertaken by North Wales Police (NWP). It seeks to ensure that best practice sustainable procurement and contract management is applied consistently throughout the Force.

The procurement department recognises the importance of supporting the delivery of operational policing. This Procurement Strategy will contribute to Force performance by ensuring that the right goods, services and works are delivered to the right people and place at the right time, at the right cost and in the most cost effective way.

2 Procurement & Contract Management

The procurement department also supports North Wales Fire and Rescue Service (NWFRS) with the delivery of their procurement requirements.

The procurement and contract management process spans the whole cycle from identification of a requirement for the acquisition of goods, services and works, through to the end of a services contract or the end of the useful life of an asset and its subsequent disposal.



On the assumption that a business case and budget have been approved, the procurement department provide a service – providing both strategic and practical advice and support - to assist in the above by:

- The identification of the best method to acquire the goods, services and works.
- Managing the tender process.
- Seeking appropriate approvals to award the contract.
- Ensuring the appropriate contract is in place.
- Advising clients on the appropriate contract management regime or for some force-wide contracts managing the contract on behalf of the Force.

3 Strategic Aims

The aim of this strategy is to support the Forces mission which is making North Wales the Safest place in the UK.

All procurement processes will:

- Support operational policing and the objectives of the Office of the Police and Crime Commissioner (OPCC) Policing Plan;
 - Contribute to the achievement of corporate goals acting as a strategic partner to the senior management team on all procurement issues;
 - Respond to client requirements including ensuring appropriate vendor management is place for post contract award arrangements;
 - Demonstrate a commitment to fulfil the expectations of Police and Crime Commissioner (PCC), Chief Officers and personnel at all levels throughout the organisation;
 - Provide value for money.
 - Only be undertaken where a business requirement or need has been identified and approved at the appropriate level, including funding.
 - Be performed in accordance with true and fair competition rules. Ensure compliance, transparency and fairness;
 - Be underpinned with the guidance developed by the National Police Chiefs' Council (NPCC) and other government agencies.
 - Demonstrate a commitment to both local and national collaborative arrangements where there is a clear benefit to the force.
 - Demonstrate a consideration will be given to health & safety, equal opportunities, business ethic, human rights, sustainability, social value and workforce issues when undertaking any procurement activity.

4 Guiding Principles

The guiding principles that support our strategic objectives are:

- Demonstrate best value in the goods and services we procure, and ensure through accurate specification that we only purchase what is necessary.
 - Demonstrate efficient processes that minimise the cost in the procurement and contract management processes.
 - Make savings on the goods and services we procure and reduce our costs by collaborating with other organisations.
 - To collaborate on a national level with National Procurement Service for Wales (NPS), Crown commercial Services (CCS), National Police Chiefs' Council (NPCC), Home Office and the other police forces on all procurements so as to ensure the best value for money.
 - We will work with the Bluelight Commercial Organisation to purchase large spend and strategically important goods and services.
 - We will honour our contractual commitments and expect our suppliers to do the same.
 - We will attempt to resolve contractual disputes amicably and fairly.
 - When dealing with suppliers and contractors we will be courteous and helpful.
 - We will respond promptly and positively to complaints, comments and suggestions.
 - On request, we will debrief successful and unsuccessful bidders promptly of the outcome of a tender, giving constructive feedback.
 - Commercial relationships will be based upon co-operation; we will seek to avoid adversarial and confrontational relationships.
 - We will raise awareness of Force Policies and legislation relating to Diversity and Social Value.
 - We will exploit the purchasing powers of national and regional procurement, identifying other, non-police, frameworks which offer value for money.
 - We will review potential contracts which may represent better value if brought in house as well as supporting reviews of in house provision which may be better outsourced or shared.

- We will ensure that procurement works in the most efficient way, within all relevant Legislation, to match its resources to where the greatest value can be added.
 - We will utilise appropriate framework agreements that may provide a quick route-to-market, reducing cost in the process. Experience has shown that not all framework agreements represent good value for money and assist in achieving the strategic objective of the project however each agreement will be reviewed prior to any other procurement route being adopted.
 - We will review pre-qualification & tender documents, terms and conditions and purchase orders, review insurance, parent company guarantee requirements, data protection requirements etc to ensure that they are not over bearing but relevant.
 - We will aim to support the local economy whilst potentially offering more flexible and dynamic product and service delivery.
 - We will ensure appropriate due diligence is undertaken prior to entering contractual arrangements.
 - To provide management and guidance for all types of procurement so as to ensure the most cost effective balance is achieved to meet the operational and business needs of the Force.
 - Where practicable and permissible, increase the number of goods and services procured from local enterprises including small, medium and voluntary sector to contribute towards a sustainable procurement environment which stimulates business in the local economy.
 - Ensure customers and suppliers find it easy to do business with us because bureaucracy of our process is minimised and that our suppliers and contractors share our vision and values and work with us to implement and deliver value for money in support of operational policing activities and the Police and Crime Plan.
 - To adhere to our obligations under the Public Sector Equality Duty by actively encouraging and supporting equality and diversity in the procurement process.

5 Management & Working Practices

- Procurements will comply with the all relevant Laws, NWP, PCC Standing Orders and financial regulations.
 - Purchasing Policy published on North Wales Police Force Governance and Policy Homepage will be properly maintained and regularly updated to ensure continuous improvement.
 - Procurement activity will respond to market intelligence and commercial awareness.
 - Procurement will be based upon arrangements in which both the NWP, PCC and their suppliers seek to gain mutual advantage.
 - Innovative partnership arrangements will be encouraged with suppliers and other sector organisations.
 - Best value evaluation criteria driven by desired outputs will be adopted balancing quality with whole life costs.
 - All procurement decisions will be recorded and clear audit trails established in order to ensure openness, propriety and probity.
 - Understanding the difference between strategic and transactional procurement will identify the different skills required for each.
 - Clear contract management systems will be applied in order to monitor performance over the whole life of a contract.
 - Where contracts can be categorised e.g. fleet, forensics, facilities etc. the procurement team will work with a nominated representative(s), the client, to identify and progress a procurement plan for tendering and managing contracts appropriate to each category.
 - In contract negotiations the philosophy will be to allocate risk to parties best able to manage it.
 - Standard documentation will be utilised and professional practices and procedures adopted using latest technology.
 - Procurement expertise will develop and only best practice techniques will be adopted to ensure continuous improvement.
 - Procurement section staff will be continually trained in best practice methodology.

6 Social Value



The department has worked with the OPCC to develop a Social Value Policy which aims to embed the culture of ‘thinking social value’ in all of our procurement and commissioning activities. Social Value requires the PCC and the Force to look beyond the basic cost of awarding a contract or commissioning a service to look at the potential collective benefit to the local community.

The Social Value Policy outlines the social, economic, and environmental outcomes that all parties are aiming to achieve, including supporting the local economy wherever possible, spending locally, and creating employment opportunities for local people.

The PCC has requested social value is incorporated into all tenders including but not limited to:

- Social Value
- Environment
- Real Living Wage.

6.1 Ethical Procurement Strategy

The department's Ethical Procurement Strategy will cover a number of key themes related to corporate social responsibility including:

- Bribery and corruption;
- Fraud;
- Modern slavery;
- Sustainable procurement.

It will include identifying risk in the supply chain, prevention, auditing, education of customers and suppliers, and the importance of the corporate Code of Ethics.

6.2 Sustainability Procurement Strategy

- Effective sustainable procurement practice will be embedded within the procurement processes.
- Procurement activity will be outcome-focused with well-defined deliverables that cover environmental, social and economic issues such as reducing CO emissions, promoting equal pay and providing opportunities for SMEs and other diverse suppliers.
- Any deliverables agreed as part of a tender process will be included in the Key Performance Indicators for the supplier to report against.

6.3 Environmental Procurement Strategy

- We will attempt to procure goods and services in a responsible way, both environmentally and ethically, working towards achieving sustainable procurements where ever possible in support of the forces Corporate Social Responsibilities (CSR).
 - We will be positive in our approach to the way we conduct business and consider the elements in which we operate namely;
 - Our own work environment (energy consumption, sustainable sources)
 - The market place where we trade (local suppliers, products, collaboration)
 - The local environment (pollution, noise, emissions)
 - It will outline how the purchase of goods and services can impact the environment, and will examine whole life principles in evaluating environmental issues.
