I am writing under the Freedom of Information Act 2000 to request the following information from January 2022 to December 2024:

- 1) A list of use of force incidents that occurred in public order scenarios, using the following tactics: limb and body restraints, ground restraints, irritant spray, spit guards, Conducted Energy Devices (CEDs; such as tasers), and Attenuating Energy Projectiles (AEPs; such as baton rounds).**
- 2) Regarding CEDs and AEPs, could you please specify whether instances where this equipment was used involved the device actually being fired or simply drawn.**
- 3) Please could you include a brief description of each incident?**
