CIRCUMSTANCES ARE DP HAS DRIVEN TOWARDS A MARKED POLICE VEHICLE DRIVING ON THE WRONG SIDE OF THE VEHICLE. OFFICERS HAVE THEN STOPPED THE VEHICLE AND HE HAS PROVIDED A ROAD RIDE BREATH SAMPLE OF 69.

DP WAS ALSO SHOWING AS UNINSURED

DP HAS BEEN ARRESTED FOR DRINK DRIVING.
