2026/807 - Menai Suspension Bridge

In response to your recent request for information regarding;

I will appreciate the expediting of this request for information, please, as it is an urgent matter and I feel is more of a request for information outside the scope of the FOI Act, but this appears the easiest way to ask you.

The Menai Suspension Bridge had a publicised full closure that was to last 28 hours, running from 2:00 PM on Friday, May 15, until 6:00 PM on Saturday, May 16, 2026.

During this time various speed cushions were installed along both carriageways of the highway on the Gwynedd side, on the Isle of Anglesey side, and on the bridge itself.

**The relevant regulations are
The Highways (Road Humps) Regulations 1999**

At 3 it states

Consultation about road hump proposals

3. Where the Secretary of State or a local highway authority proposes to construct a road hump, he or they shall, as well as consulting the chief officer of police as required by section 90C(1) of the Act,...
